AMERICA'S TOP SCIENCE TEACHER HONORED AS ALUMNUS OF THE YEAR

Edward E. "Ed" Evans '82 received your Alumni Association's prestigious Alumnus of the Year award on Saturday, April 25, 2009. Evans, who teaches science at Mount View High School in McDowell County, was given this high honor recognition, that has been awarded annually since 1955, at the evening's annual Alumni Banquet. The award is given to a Glenville graduate who has made outstanding contributions in his/her field of study or for outstanding personal accomplishments.

This latest honor comes after Ed was named **America's Top Science Teacher** at NASA's Goddard Space Flight Center when NASA hosted the Discovery Education and 3M competition October 3-6, 2008. Evans, a veteran 27-year school teacher, beat out educators from across the nation to capture this national science teacher award.

During two days of competition, he participated in multiple rounds of space-themed challenges that were judged by several 3M scientists and NASA representatives, including a former astronaut. These challenges involved doing everything from simulating a moon walk to designing a fuel mixture for rocket sleds.

There were actually eleven challenges. The first one involved having to use lasers and map the surface of Mars. On the second one, they were supposed to send up a space shuttle with the repair crew for the Hubble Space Shuttle. (That was delayed due to some camera equipment problems.) Ed and the other finalists were with the astronauts and flight crew that were working on this project. They had to design repairs that could be used when they go up to make the repairs. They also had to simulate a walk on the moon.

As part of the national award, Mr. Evans not only was named the **nation's top science teacher**, but he received a \$5,000 cash prize and a Discovery Education multimedia service set including video-based learning products for the classroom, plus numerous products from 3M to be used at Mount View High School. As part of this competition, teachers were challenged to make their own videos explaining space-related concepts, including Newton's Laws of Motion, acceleration, aeronautics, centrifugal and centripetal force, and scope and scale. From this competition, the national finalists were chosen.

Ed has been recognized by the West Virginia Department of Education and Governor Joe Manchin for this national honor. Mr. Evans, the president-elect of the West Virginia Science Teachers Association, is a past recipient of the Arch Coal Award. He was named the McDowell County Teacher of the Year in 2000 and is a previous Potomac Region Solar Energy Educator of the Year recipient who had two students to win the National Solar Energy Design contest in 2000.

Ed has served on the executive board of the Buckskin Council Boy Scouts of America and is a former president of the Welch Kiwanis Club. He resides in Welch with his wife, **Lynda "Pip" Luikart Evans '82**, and their two children, McKinsie, a student at Mount View High School and Brandon, a student at Welch Elementary. Evans was an active member of the Theta Xi Fraternity while pursuing his Bachelor of Arts degree in Education from GSC.

GSC Greats Inducted into Hall of Fame

On Saturday, May 16, 2009, Glenville State College inducted five new individuals into its Athletic Hall of Fame, which was established in May 2001 through the generosity of the late **Curtis Elam, a 1949 graduate.**

This year's inductees were:

Larry "Doc" Stanley '59, a native of Belle and a standout athlete at Dupont High School. "Doc" was presented by his former coach and 2001 Inaugural Hall of Fame Inductee **Bob "Hooks" Hardman '51**. He lettered in football (4 years), basketball (2 years), and track (1 year) at GSC. A running back for the Pioneers, "Doc" was the leading scorer in 1956, an ALL WVIAC Performer in 1956 and 1957, ALL WVIAC in 1958, and the top rusher on the 1958 Undefeated WVIAC Championship Team (6-0-1). "I had no intentions of going to college", "Doc" said during his induction, "but I found my way to Glenville State College and I truly cherish my time as a Pioneer." Larry went on to enjoy much success in his 40 year career with ConAgra Foods, Cincinnati, OH, where he served as the company's National Sales Manager during the last ten years of his employment. Now retired, he continues to be very active in sports, playing in two senior softball leagues every week, all year around. He is the manager/player on one of these teams. Larry and his wife, Delores, will observe their 50th wedding anniversary on December 11, 2009. They reside in Cincinnati, OH and are parents of two children, Jeff, the oldest, graduated in 1985 from Bowling Green State College in Ohio and is self employed, working with computer hardware/ICS systems and Laura, who graduated from Eastern Kentucky in 1990, is employed as a fireman paramedic in Northern Kentucky. The Stanley's have five grandchildren.

Tom Gunnoe '64, a native of East Bank, lettered in football (4 years), basketball (2 years) and baseball (1 year) at Glenville State College. He was ALL WVIAC in 1961,

Second Team ALL WVIAC – Offense in 1961 (Running Back), First Team ALL WVIAC – Offense in 1962 and 1963 (Running Back), First Team ALL WVIAC – Defense in 1963 (Corner Back), Captain of the 1963 Football team, a member of the ALL WVIAC team and an ALL American in 1963. Additionally he played on the ALL Opponent Team (Westminster, PA). Tom told the crowd during his induction that "Once a Pioneer, always a Pioneer – that GSC calls us back home no matter how far we go." Gunnoe taught and coached for a couple of years in Kanawha County and played for the Charleston Rockets – Continental League (1964-66) before joining the National Football League and playing for the Cleveland Browns (1966-1968). Tom received a master's degree in guidance and counseling from WVU and enjoyed a long career in administration with the West Virginia Department of Health and Human Resources, retiring in 2002. He was awarded the Distinguished West Virginian award at the time of his retirement. Tom and his wife of 45 years, Linda, reside in St. Albans with their daughter, Tonya Renae Gunnoe. Their son, Dr. Thomas Brent Gunnoe; daughter-in-law, Trecia Bruffy Gunnoe; and granddaughter, Leah Marie Gunnoe, reside in Palmyra, VA. GSC's former head baseball coach/former assistant football coach Dr. J. William "Bill" Douglas, of Morgantown and Florida, presented Gunnoe to the Hall of Fame.

Larry L. Chapman '74, a native of Weston. He competed in football for the Glenville Pioneers during former head football coach Bill Hanlin's era when the 1973 football team was undefeated in the WVIAC regular season (9-0). The team lost one playoff game before going on to become second runner up nationally. Chapman was ALL WVIAC in 1973, Second Team NAIA ALL American in 1973, and Offensive Lineman on the 1973 NAIA Runner-Up Team. Larry taught in Calhoun and Preston County schools before pursuing a career with Equitable Gas (now EQT Midstream) as a Safety Director. He currently serves as Manager of Technical Training for the company and travels extensively in his job. Chapman is a member of the American Society of Mechanical Engineers and the American Society for Training and Development. Larry and his wife, **Suzanne '74**, reside in Lost Creek. They are parents of two children, Satsha Chapman Poling of Anmore and Mason Chapman of Orlando, FL. Due to a serious family illness, Larry was unable to attend his Hall of Fame induction. Presenter **Bill Hanlin '53**, 2001 Inaugural Hall of Fame Inductee and former GSC head football coach, thanked everyone on Chapman's behalf.

Tina Burkhamer-Cunningham '87, a native of Linn, was inducted into the Hall of Fame for her accomplishments as a member of the Lady Pioneer basketball and volleyball teams. Versatile and noted for her deadly jump shot, Tina was First Team ALL Tournament in 1985 and 1986, Second Team ALL WVIAC in 1985, First Team ALL WVIAC in 1986, Team Scoring Leader in 1985 and 1986, and Career

Average Scoring Leader in 1986. Additionally, Tina was co-captain of her basketball team during the 1985-1986 season and received the prestigious Clarissa Williams Award in 1987. "All I ever dreamed about was playing basketball, and thanks to Glenville State College, my dreams came true" said Burkhamer-Cunningham at her induction. After graduating from GSC, she served as the College's Sports Information Director from 1987-1992; Assistant Women's Basketball Coach from 1987-1991; and as Co-Volleyball Coach in 1987. Tina and her husband **Greg Cunningham '87**, reside in Troy with their three sons: Tyler, Austin, and Colby. She was presented for induction by **Tim Carney '62**, her former women's basketball coach, 2005 Hall of Fame Inductee, former GSC athletic director, former men's golf coach, and Professor Emeritus.

Kim Creel '90, a native of Ravenswood, competed in basketball (4 years), volleyball (2 years), and track (1 year). She was Second Team ALL WVIAC in 1988 and 1989 in basketball and was on the first Lady Pioneer Basketball team to advance to the NAIA National Tournament. Kim received Honorable Mention ALL WVIAC for Volleyball in 1987, was Second Team ALL WVIAC for Volleyball in 1988, Outstanding Young Woman for Volleyball in 1988, WVIAC Champion for Discus Throwing in 1986, placed second in the WVIAC for Shot-Put in 1986, and third in the WVIAC for Javelin in 1986. Kim received the prized Clarissa Williams Award in 1990. During her induction, she commented "For me, Glenville State College is about the wonderful, caring people there. My life has been forever influenced and enriched by many of those people." Kim is pursuing a master's degree in counseling at Marshall University Graduate College, Charleston. She serves as Executive Director of the Bob Burdette Center in Charleston where she received the "Share the Vision" Community Award in 2002 and continues to secure grants for this operation. Kim and her three children: Marsha, Billie, and Issac reside in St. Albans. She was presented for induction to the Hall of Fame by her sister, Crystal Creel.

This year's class joins forty-nine past inductees and one National Championship team (bowling) that have been inducted since 2001. Competitive sports first started at Glenville in 1908 with football and men's basketball. Many other sports have been added through the years, these being baseball, wrestling, bowling, golf, track, and cross country. Competitive sports for women began in the mid 70's with women's basketball and volleyball. Other sports for women including golf, softball, track, and cross country have been added since that time. Plaques of all inductees of the Curtis Elam Athletic Hall of Fame are displayed in the lobby of the Glenville State College Physical Education Building.

The contest, on November 5, 2009, at Morris Stadium, is between our Glenville Pioneers and the Shepherd Rams. It will be at 8:00 p.m. EST. The Glenville-Shepherd Game is one of a six game football television package between Division II and CBS College Sports. This package, the fourth since Division II and CBS Sports established their partnership to give Division II schools live TV exposure for their football and basketball programs (in addition to live postseason coverage in those and other sports), is the first to feature both premium-game match-ups and conference rotation games that league commissioners help select. Glenville State College Alum **Mike Forbes '82** has made a \$25,000 gift to his alma mater's Transforming Lives NOW! Capital Campaign. "I am pledging my financial support so that future GSC students might have the same life transforming relationships and opportunities at Glenville State College as I benefitted from," he said.

Forbes is Vice President and Treasurer of Energy Corporation of America (ECA) and works in the company's East Region Headquarters located in Charleston, WV. ECA was formed by John Mork, who was recently named the West Virginia Oil and Gas Man of the Year and is the CEO and President of the company. Forbes also previously served as President of two ECA subsidiaries, Energy Centre, Inc. and Eastern Capital Corporation. He serves as Past Chairman of the Board of Saint Francis Hospital, board member of Thomas Health Systems, and board member of ECA Foundation and Eastern American Energy Corporation.

Forbes earned his Master's Degree in Business Administration from Marshall University in 1990. Additionally he completed the Financial Management Program for Senior Financial Executives from Stanford University in 1991.

Forbes came to GSC from Oxon Hill, MD. Lilly, Jr. '48**, also a GSC Hall of Famer, and just one of the many people he met at GSC that had a profound influence on his life. "Professor James and his family really became a second family to me while I was at Glenville. Professor James is gone now but I'm still very close with the rest of the family," he said.

It was also at Glenville State College where Forbes initially became involved with ECA and John Mork. Fellow GSC alumnus **Rich Heffelfinger '80** and Forbes did an internship with ECA, which led to both starting their careers with the company. Heffelfinger later left ECA to pursue other opportunities in the oil and gas industry. Forbes has spent his entire career with ECA, which is one of the top 100 oil and gas companies in the country. "There were so many members of the GSC community that have

made a positive difference in my life. I would not be where I am today without them or Glenville State College,” said Forbes.

GSC Joins Forces with JASON Project

Through a partnership between Glenville State College and the JASON Project, dozens of West Virginia teachers are receiving special training in science that they will utilize in their classrooms.

The JASON Project is a nonprofit subsidiary of the National Geographic Society, in partnership with the National Oceanic and Atmospheric Administration (NOAA), National Aeronautics and Space Administration (NASA), the Department of Energy, and other leading organizations. JASON embeds the cutting edge research of its partners into core Science curricula and professional development. JASON connects young students with great explorers and great events. Its core curriculum units are designed for 5th through 8th grade classrooms but are flexible enough to be adapted for higher or lower grades.

Glenville State College has partnered with the JASON Project to enhance the efforts of GSC’s Hidden Promise Consortium goal of unlocking the “hidden promise” of K-12 students in the participating counties. The partnership has been financed for one year through special congressional funding arranged by Congressman Alan B. Mollohan. New funding is being sought to continue the partnership for an additional two years. “We are thrilled to be partnered with Glenville State College in our effort to create highly qualified teachers by increasing the knowledge of science and preparing them to inspire and motivate their students through use of the JASON Curriculum. The goals of the program blend seamlessly with those of the GSC Hidden Promise Consortium,” said John J. Gersuk, Executive Vice President, Government Relations, National Geographic Society – JASON Project.

Two JASON curriculum teacher training workshops were held at Glenville State College in June 2009. Each two-day workshop featured professional development designed to increase the teachers’ expertise in implementing inquiry-based science curricula in the classroom. The teachers attending the free workshops were recruited by their Principal or Superintendent in their county. Teachers were trained in three JASON curriculums: *Resilient Plant*, about the Earth’s critical ecosystems; *Monster Storms*, the science of extreme weather; and *Infinite Potential*, the current and future challenges of energy. The workshops were conducted by JASON Project Lead Trainers, who are top science educators certified as Lead Trainers after completing an extensive Lead Trainer program in science, professional development, and the JASON curriculum. The experts are sent around the world by JASON to prepare their colleagues to implement JASON in the classroom.

New Criminal Justice Major Offered

One of the more than sixty teachers who attended the June workshops was **Ronald Chadwell '77**, a 7th grade teacher at Geary Elementary School in Roane County. "It is fantastic that we have been able to attend the JASON Training at Glenville State College. Without GSC and Congressman Mollohan, this training would not have been available to us. I am looking forward to implementing this curriculum to get my students more involved and excited about learning," said Chadwell.

Another one-day curriculum planning workshop was held at GSC on August 20, 2009 prior to these teachers taking what they have learned into the classroom. Teachers who completed the training received curriculum materials for their classroom. Additionally, a JASON Project training workshop was held at GSC on Friday, August 21st and Saturday, August 22nd. The JASON Project will provide continuing support to the teachers and their classrooms throughout the school year.

Although a date has not yet been announced, Dr. Robert D. Ballard, founder and Chairman of the JASON Project, will visit Glenville State College in the Spring of 2010 to promote the partnership.

"Glenville State College and the Hidden Promise Consortium are very excited to offer the JASON Project for 5th – 8th grade science teachers. As a former superintendent, I know that there are not very many programs or support for science teachers that are as exciting as the JASON Project. Research shows that many students in middle school are bored in every class. The students will definitely not be bored with these teachers and the science units. The teachers that have been trained are excited and motivated to teach their students the curriculum," said **Ed Toman '91**, GSC's JASON Project Director and Hidden Promise Consortium Coordinator.

Glenville State College is in the process of developing a program with the JASON Project that would allow science teachers to earn a Master's Degree through a series of on-line and summer classes. It is hoped that the program will begin in early 2010.

Glenville State College is adding one new major and three new minors to the growing number of courses of study offered at the institution. Beginning with the 2009 fall semester, Glenville State College will be offering a new four-year Bachelor of Science degree in Criminal Justice providing students both a high quality academic curriculum and an array of hand-on-experiences. Previously, GSC offered a Bachelor of Science Degree with a concentration in Criminal Justice, but no stand alone degree. Students will experience a general overview of the criminal justice system, while gaining specialized knowledge in two of the three criminal practice concentrations: law enforcement, corrections, and investigative science and technology. Criminal Justice majors will also be required to complete a full term internship related to their concentration before graduation. Almost thirty students have already registered for the new Criminal Justice program. GSC will continue to offer a two-year Associate Degree in Criminal Justice.

"We are excited that GSC now offers a Bachelor of Science Degree in Criminal Justice. Graduates of the program will be more marketable in their search for employment," said Criminal Justice Department Chair Dr. Jami Myers. Most federal agencies require employees to hold a four year degree.

In addition to the new Criminal Justice degree, GSC is also offering three new minors: Information & Media Studies, Outdoor Recreation, and Nonprofit Leadership and Management.

"Glenville State College has a history of trying to be responsive to student needs and requests. Our new Criminal Justice major is a unique program that we anticipate will be a big draw for GSC. With options within the program, students will have an opportunity to specialize in an area of interest. With the additional hands-on component of our new program, we expect that our program graduates will be sought after across the state. The outdoor recreation minor ties so closely with the emphasis of tourism in West Virginia that we expect it to be very popular. Other students have asked about courses and programs in fields such as electronic media, nonprofit leadership and management, and physics. This year, our faculty was able to develop minors in these areas as well, providing more choices for our students," said **Dr. Kathy Poling Butler '76**, Glenville State College Provost/Senior Vice President.
