#### To Be Signed at the Institution

The student must appear in person at Glenville State University to verify his or her identity by presenting an unexpired valid, government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. ### To Be Signed With Notary
